#### **OFFICER'S REPORTS:**

## Commandant's Report: Ray Rayl

## Junior Past Commandant: Art Menard

On October 12<sup>th</sup> Menard emailed the Board Members, about his main "mission" is advising the New Commandant. Also talked about Central Division Conference for 2024 in Kalamazoo and the committee. Stated that for this to be successful, that we need all the Detachments to participate and to take out ad's—also this is the first time ever trying electronic registration. \$115 per room all inclusive and free parking there is a good team in place for this event. Possibility having the Summer Convention in June in Kalamazoo too. Reminded about PLM Roster that is due by December. We also need somebody to look at the Department By-Laws and find what it states for holding a quorum for meetings, and if our By-Laws need to be changed need to be submitted by April to be in place for Summer Convention. Attended National Convention was a great event, the National Ribbon you can get 100<sup>th</sup> numbers to put on your ribbon (at a cost). Also be careful what you are posting on Social Media and make sure your uniforms are in proper regulation order and flags too.
