## REPORT OF OFFICERS

COMMANDANT'S REPORT – THE COMMANDANT THANKED THE CASCADES DETACHMENT FOR HOSTING THE 2023 MID-WINTER RALLY.

WE ARE ACCEPTING TWO DETACHMENTS VOLUNTARY SURRENDER OF THEIR CHARTERS. THEY ARE THE NORTH OAKLAND COUNTY # 570 AND THE ST. JOSEPH COUNTY DET. # 1401, THE ZONE COMMANDANTS HAVE BEEN WORKING WITH THE DETACHMENT COMMANDANTS ON WHAT NEEDED TO TAKE PLACE TO CLOSE. ACTIVE PARTICIPATION FROM THEIR MEMBERSHIPS WAS NOT HAPPENING AND THEY SIMPLY COULD NOT FUNCTION AS A UNIT TO MEET THEIR REQUIREMENTS ANY LONGER. THE STATUS OF BOTH WASHTENAW 414 AND SGT G.P. ALL DETACHMENT OFFICERS NEED TO TRY TO REACH OUT TO THOSE MARINES AND DETERMINE WHAT IS THEIR "VARIOUS REASON" FOR LEAVING THE LEAGUE.

BOTH HAVE BEEN FRIENDLY AND SUPPORTIVE OF VETERANS ISSUES IN THE PAST.

FOR 2022-2023 BUDGET – VETERAN SERVICES GRANTS – NO CHANGE

FOR VETERAN SERVICES GRANTS APPROPRIATIONS IS \$4,250,000

\$250,000 WAS APPROPRIATED TO ESTABLISH A FEASIBILITY COMMITTEE FOR A STATE VETERAN CEMETERY TO BE BUILT IN A U.P. COUNTY WITH NO LESS THAN A POPULATION OF 12,500 AND NO MORE THAN 13,700 WHICH MEANS GOGEBIC COUNTY ON THE WEST END OF THE U.P. \$12,000,000 IN FEDERAL GRANTS IS AVAILABLE FOR THE STATE FOR CONSTRUCTION OF THE CEMETERY. IT HAS BEEN REPORTED THAT THE MICHIGAN LEGISLATURE HAS APPROVED FUNDING FOR A NEW VETERAN HOME TO REPLACE THE JACOBETTI HOME IN MARQUETTE.

INCLUDED IN THIS REPORT ARE THE LEGISLATIVE PRIORITIES OF THE MICHIGAN COMMANDERS GROUP. THESE ARE IDEAS VETERAN ORGANIZATIONS SHOULD ADOPT FOR THE NEW LEGISLATIVE SESSION. THEY ARE ATTACHED TO THE REPORT SUBMITTED.
