The end of June Tippett and Menard attend Keweenaw Detachment 1016 meeting to present DD Tim Smigowski with his Pack Dog award from Summer Convention—stated they have a large

Detachment Membership and very few at meetings. All the Detachments participated in Memorial Day Services and numerous 4th of July events. Still working on the Compliance with Detachment 550. September 21 held UP Zone and Devil Dog meeting in Escanaba, decided at previous zone meeting to start rotating to where the Zone Meetings will be held. Stated attendance not the greatest but hoping more key members start getting more involved. Detachments are planning Birthday Celebrations—UP 444 will be having a big event at the Casino for the 249th Birthday Celebration on November 9th. Also the UP Honor Flight is planning on putting on an all Female Veteran Honor Flight.

Finally attended the National Training for Toys For Tots that took place September 12-15th in St. Louis Missouri—they took the show on the road. It went well, lots attended, over 878 toy campaigns throughout the US. The hotel was just across the street from the Arch. They are planning on holding the event there again next year. Also sent out a list of all the counties in Michigan that do not have toy campaigns, maybe some of your detachments are look into helping them out. That is the end of my report.

SR. Vice: Phil Smith

Proposed to do a Department raffle to raise some funds, doing this raffle: 1st prize \$10,000, 2nd prize \$3000 and 3rd prize \$500, and will be selling tickets for \$10 a piece. Discussion took place about doing raffle, the how's and when's of it. Was suggested that this go under new business. Trying to help out Detachment 414 and points of contact are not there. JR. Vice: Stephen Fletcher

Currently we stand at 1,442 paid members (1284 regular + 138 Associate +20 multiple). We have 440 unpaid members (330 regular + 110 associate). Fletcher suggests to reach out to them and get them back into the fold. We need to connect with Members from 163, 414, 841, 570 and 1401 to get them moved to other Detachments in Michigan, otherwise they will turn into members at large and belong to the National Roster. Remember to start recruiting to grow the league and strengthen our numbers. Membership year runs September 1 thru August 31st.

Also stated coming up with be an internment at Great Lakes Cemetery for a recipient of the Congressional Medal of Honor from the Indian War Campaign. Headstone cleaning will also be taking place on 10/19. This concludes my report.

Paymaster: Larry Sweerin

Out of 32 Detachments, only 8 have turned in the PLM (paid life membership) audit reports and they are 154, 159,444,764, 1016, 1027, 1327 and 1423—the deadline to be turned in is by December 31st. Changed the budget slightly from last year a few items have risen. Changes to the Commandant's Discretionary Fund and Commandants Travel might have to be adjusted more down the line. Profit and Loss is just about the same as it was before. Assets and Liabilities they balance out. Fund reconciliations balance out and investments they are self explanatory and are continuing to do well.

Judge Advocate: Scott Hellman

Since the Summer Convention there was one By-Law Change and has been implemented in the By-Laws and Posted. Also adapting the By-Laws to read as he/she gender related. In the process of

going over changes that National implemented to make sure we are in compliance with them also. Any new By-Law changes need to be presented at Mid-Winter. And if you have a "clubhouse" make sure insurance and license needs to get sent to Adjutant and Judge Advocate to make sure you are in compliance.

Central Division ADVC: Jeff Krakow

Central Division National Vice Commandant Dave Englert encouraged all Central Division representatives to attend meetings to have representation. NVC Englert big push this year is on recruiting and membership. As of 3 October, Michigan is at 81.8 percent on its membership. Englert also is adding to his staff—A Youth Physical Fitness-Ben Mattson, Membership Chairman—Christopher Taylor, Compliance-Roger Smith, Veteran Service Officer—Tim Sherman, and Website—Dan Tolson. Also there are new Honor Guard procedures on National's website—look them over. Finally stated we all need to start keeping track of our man hours—Color Guard/Honor Guard, VA visits, toys for tots, parades etc etc. anything you do to help your community or state as a Marine Corps League Member.

Recently updated forms that National updated onto the website. Soon will be placing the Mid-Winter packet on there as well. Two years ago we transferred the budget from VAVS to the Foundation, and realized the \$5000 wasn't going to be sufficient enough budgeted, and then added a new Veteran's Home in Chesterfield and the \$500 wasn't going to be enough. So, as a member and trustee of the Vietnam Veterans of America Chapter 9, petitioned for a grant, and was successful in receiving a grant \$2500 that will go towards VAVS services this year. Hopefully this will go further and bigger in the future. Additionally six years ago we were given a grant for \$1000 for scholarships from the Chapter. That was so successful they extended that and gave us a check for \$10,000 for five years and this is the last year of those funds. They are so happy for what we have done, that we were assigned for the Foundation a continuation of the memorandum of understanding and have given a check for \$25,000. Great work.

Foundation: Jeff Salzeider/Gerald Alcorn

Tried to have a meeting to get a few things taken care of: Department \$5500 needs to get transferred to the Foundation account to replace that was spent on the VAVS donations to the Foundation since it has taken it over. \$5500 going out this year to 7 facilities and a specific dollar amount is earmarked for each home, plus an additional \$2500 will be divided out between them. Salzeider will get with the VAVS reps to write them a check to give to these facilities. Lara Corp has been filed, and the summary for the 990 has been turned over to the accountant for a review and proceed from there. Donation made today of \$25,000, the next five years for \$5000 each year for scholarships. In the account is \$36,904 and \$1687 in savings account. In the operating fund there is \$20,473 separated into accounts.

Alcorn wanted to say Thank You for being here. Spoke about the Legacy Program, free account, www.tango3.org, Military Legacy Project to go on there and tell your story. Encourages everyone to let them know what we are doing. Tell them to take advantage of this, share whatever about your history.

Question was asked what we are doing to raise funds for the Foundation. Nothing at the moment, trying to fix previous issues and moving forward from there and getting ducks in a row.

Good of the League:

Marine of the Year is coming up again, we are going to follow what National is doing and

Central Division and having previous members voting but we have to change the By-Laws on how it is run. In the end going to try to do it all electronically. Finally if you know of an older Detachment Marine or Veteran celebrating a milestone birthday, make sure you are doing a big to do event and helping out.
